Multi Child Discounts

Option 1 for families with 3 children \$ 500 per family

OR

Option 2 for families with more than 3 children \$2,000 per family

- Families must have a balance due after scholarships, grants or other financial aid to qualify for multi child discounts.

Financial Assistance Financial Assistance comes in several forms. We have the State of Ohio Ed Choice Scholarships (Traditional & Expansion), the Archdiocesan Catholic Education Foundation (CEF), and Our Lord Christ the King Parish/Cardinal Pacelli School scholarships. If you are planning ahead for next school year and feel you may need some financial assistance, please take a few minutes to apply for the CEF by February 1st. The Ed Choice Scholarship renewals begin sometime in February. To qualify for Our Lord Christ the King/Cardinal Pacelli School Tuition Assistance you must first be a parishioner of Riverside Catholics (Christ the King, St. Rose, Holy Cross Immaculata, or St. Stephen) and you must have already applied for both the CEF and Ed Choice.

Please do not delay in applying for the CEF. Both the Our Lord Christ the King Parish/Cardinal Pacelli School Tuition Assistance Program and the CEF (Catholic Education Foundation) scholarships are needs-based. You must apply first for the CEF through FACTS by following this [link](#). **The deadline to apply for the Catholic Education Foundation Scholarship (CEF) is TBD, we recommend applying before February 1st.**

Elementary School Tuition Grants – Preschool – 8th Grade With the changes to Ed Choice, this program is being adjusted to have further reach. Preschool (does not include Daycare) students will now be eligible for a tuition assistance grant from the CEF. These scholarships are needs-based and will include families up to 649% FPL. These changes should help to better support financial needs, especially those families with a student on Jon Peterson. The maximum scholarship amount will be at least \$1,200, with final awarding levels being voted on in February. Families will continue to complete a FACTS Grant and Aid application to be considered for this assistance. **The deadline for applying is TBD, we recommend applying before February 1st.**
